

Centralise your Documents





Many companies have gone digital with tools like SharePoint or Dropbox, thinking it's efficient – and compared to paper records, it is. But fully managed document systems, especially those tailored for rail, take things further. They save time, streamline workflows, and crucially, ensure you're audit-ready for ISO and RISQS compliance.


Use a digital document management system to store all records in one place, with automated revision control to ensure you're always using the latest versions. capturing evidence on tablets for field engineers makes the integration from office to site seamless. Digital acknowledgements are widely accepted by RISQS auditors

Automate Training & Competency Tracking

Implement a system to track training records, send notifications for expiring certifications, and store digital copies of all documents.





Ensure Fatigue Management Compliance





Fatigue management is a key focus of RISQS audits, especially the planning element with standards like NR/L3/003/OH. Non-compliance can result in fines or safety incidents, and auditors will expect detailed records of staff hours and fatigue protocols.

Use a system to monitor staff hours, enforce fatigue protocols, and maintain auditready reports, if your currently manging this on a spreadsheet you are burning money and resources in unnecessary admin.




IMS's Fatigue Management feature integrates with timesheets and labour rostering to enforce compliance, with built-in review processes and reporting tools to prove adherence during audits.



Streamline Safety and Incident Reporting



RISQS auditors will look for evidence of proactive safety management, including incident reporting and corrective actions, as required by protocols like Construction Design and Management (CDM) and Sentinel audits.



Digitise safety reporting to capture near-misses and incidents in real time, with analytics to identify trends.



IMS's Good Call Close Call feature allows targeted observation reporting across all platforms (or via QR scan), with analytics to track incident statistics and custom categories for detailed insights.

Prepare Audit-Ready Reports and Audit Trails



RISQS auditors require clear, organized evidence of compliance, including audit trails for accountability, especially for high-risk activities on Network Rail's infrastructure. Manual reporting can take hours—or even days.




